Biome to launch into UK and Ireland health retail markets

- Launch of Biome's Activated Probiotics into key European health retail channels is commencing in January 2024
- Key European distributor partners include CLF in the United Kingdom and iiHealthfoods in the Republic of Ireland
- Biome will fund its expansion into European markets from existing working capital

Microbiome health company **Biome Australia Limited** (ASX: BIO) ('Biome' or 'the company') is pleased to announce that its first allocation of Activated Probiotics® has commenced delivery into pharmacy and health retail stores in both the United Kingdom and the Republic of Ireland. The allocation follows the recent signing of distribution agreements with UK-based CLF and Ireland-based iiHealthfoods.

As part of the agreements, the full Activated Probiotics® range will be stocked at CLF and iiHealthfoods' distribution centres to supply products to health retailers nationwide.

Biome's European launch will build on Activated Probiotics' success in the Australian market, replicating the company's unique sales and education model as well as maintaining practitioner-only positioning. Biome's own team will manage all aspects of training, support and customer service to ensure the model is consistent with the Australian market.

Biome's expert European team of sales and education professionals has been built slowly and with consideration. The team's collective extensive industry experience uniquely qualifies them to lead Biome's current and future European market launches. Notably, sales efforts will be led by Biome's Regional Sales Manager, whose professional experience includes leading the sales team of one of the UK's largest probiotic brands.

Following a successful test market phase in both countries with a focus on independent health practitioners, Biome now has a strong foundational customer and revenue base. Biome is confident that both markets have been sufficiently de-risked and represent a strategic opportunity to scale beyond Australian borders.
